2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organizes special Programmes for advanced learners and slow learners

Student representation is diverse not just in terms of regional and linguistic aspects but also their level and pace of comprehensibility. Since it would be inappropriate to divide a class into groups based on students' level of comprehension, classroom observation, interaction, continuous and periodic assessment are used as a measuring system to assess learning levels of the students.

Every departments draw up the schedule for organising remedial classes for slow learners. This exercise is done in a discreet manner and slow learners are encouraged and prodded to recognize their shortcomings and register on their own without compulsion. Teachers are able to give one to one attention in remedial classes and focus on individual problems in a better manner when compared to a regular classroom in which the advanced learners' participation may inhibit the others from voicing their problems.

The departments use monitoring and mentoring to keep track of slow learners' progress. Alongwith teachers some advanced learners are encouraged to mentor weak students and help them with explanation and notes. Revision classes are held and additional teaching taken up if required.

Advanced learners are encouraged to study Recommended Readings listed in each syllabus. They are encouraged to maintain a journal or diary. .Online resources are made available to strengthen the knowledge-base.

Continuous internal evaluation is a vital aspect of classroom teaching. As SWAMI NISWAMBALANANDA GIRLS' COLLEGE is an affiliated college under University of Calcutta, we are not in a position to design the summative assignments. We have to abide by the end semester assessment pattern as laid out by the University of Calcutta. However, as part of teaching-learning process, Formative assessment is designed keeping in mind the digital pedagogy. MCQ type quiz in Google form are conducted weekly. Group projects are planned to encourage higher order learning. The following are some of the various ways in which evaluation is carried out:- Oral question answer sessions Class tests Midterm tests Re-test or supplementary tests when students fare badly at a given test thereby giving them another chance of improvement Assessment through viva voce Day to day assessment on class performance Continuous internal evaluation system is reformed to judge experimental skill, ability of independent thinking, preparation

for final University examinations, preparation for entrance examinations for higher studies. This is supplemented with a continuous evaluation of students through interaction in laboratory and theory classes. Occasionally surprise tests are conducted and the papers of the students are checked and corrected by other fellow students without knowing the identity of the concerned student, though the whole process is monitored by the faculty. This enables them to learn from others and correct their own mistakes.

6.1.1 - The governance of the institution is reflective of and in tune with the vision and mission of the institution

The democratic form of governance, in which the principal and conveners of various committees make choices regarding the implementation of various policies after consulting members in meetings, demonstrates how the participatory management system functions. Before the distribution of funds and resources, numerous committee reviews have been considered. The college's mission committee may have established the institution's participative management and decentralization policies. This committee adheres strictly to the guidelines established by the University of Calcutta as per the standards of the West Bengal Higher Education Department. Admission subcommittee decisions are made on a range of topics, including the online and offline admission process, contracts with vendors (software developers of admission portals), cost structures, the number of seats available for different disciplines, and the preparation and publication of merit lists during the admissions process. The college's governing board strives to promote a comprehensive learning environment. With the participation of teaching and non-teaching staff, the Principal, in her capacity as the institution's head, assumes the role of leadership in decision-making. There are twelve members in total. The Principal, who also serves as the Secretary, is joined by one President, two government representatives, two nominees from universities, three members nominated by the Teacher's Council, two non-teaching representatives, and one student representative. All academic and administrative goals and policies are carried out by the college principal with the assistance of several committees.

The Principal uses MIS to coordinate and control decisions made on behalf of the College by the Teachers' Council, Governing Body, and IQAC with various committees and subcommittees. Both teaching faculty and non-teaching staff actively participate in its efforts to further the college's development. The college's plans and programmes periodically flow through the overall development. It has been in use for both academic and non-academic purposes for a while now. Its official, non-official, and academic work includes the following:

Several institutional procedures demonstrate decentralisation and participative management, such as the admissions process, the delegation of authority to department heads, the assignment of NAAC work to teaching staff, etc.

- The university exam was administered by assigning distinct tasks to both teaching and non-teaching personnel.
- The examination committee was approved by the principal.
- The procedure involves the teaching and non-teaching staff as well. They draft notices asking pupils to fill out forms and pay examination fees. After they are sent by the university, admit cards are handed over to the students on the college premises.
- For each department, the committee creates a centralised protocol for internal and tutorial exams.
- The University of Calcutta offers the timetable for both theory and practical exams. Additionally, they assign testing locations. With the help of the non-teaching personnel, the committee organises the invigilation duties and distributes the question papers and response scripts to the invigilators in accordance with the timetable supplied by the university.
- The departments, along with the assigned examiners and scrutineers, submit the marks for internal, tutorial, practical, and theoretical examinations onto the site in accordance with the University schedule. After getting the mark sheet from the University college distributes it to the students accordingly.

In addition to their academic tasks, faculty members are allocated extra responsibilities and duties for the institute's many extracurricular activities. These are primarily volunteer assignments. The Institute gives these contributions the proper weight in their evaluation as a whole. The heads of the departments, the IQAC, the Principal, and the Promotion Subcommittee examine and validate the PBAS proforma that the faculty member filled out. Faculty members must attend prior to the screening and selection process, as their recommendations for promotions are determined on their API score.

Student representation is diverse not just in terms of regional and linguistic aspects but also their level and pace of comprehensibility. Since it would be inappropriate to divide a class into groups based on students' level of comprehension, classroom observation, interaction, continuous and periodic assessment are used as a measuring system to assess learning levels of the students.

Every departments draw up the schedule for organising remedial classes for slow learners. This exercise is done in a discreet manner and slow learners are encouraged and prodded to recognize their shortcomings and register on their own without compulsion. Teachers are able to give one to one attention in remedial classes and focus on individual problems in a better manner when compared to a regular classroom in which the advanced learners' participation may inhibit the others from voicing their problems.

The departments use monitoring and mentoring to keep track of slow learners' progress. Alongwith teachers some advanced learners are encouraged to mentor weak students and help them with explanation and notes. Revision classes are held and additional teaching taken up if required.

Advanced learners are encouraged to study Recommended Readings listed in each syllabus. They are encouraged to maintain a journal or diary. .Online resources are made available to strengthen the knowledge-base.

6.1 - Institutional Vision and Leadership

6.1.1 - The governance of the institution is reflective of and in tune with the vision and mission of the institution

The democratic form of governance, in which the principal and conveners of various committees make choices regarding the implementation of various policies after consulting members in meetings, demonstrates how the participatory management system functions. Before the distribution of funds and resources,

numerous committee reviews have been considered. The college's mission committee may have established the institution's participative management and decentralization policies. This committee adheres strictly to the guidelines established by the University of Calcutta as per the standards of the West Bengal Higher Education Department. Admission subcommittee decisions are made on a range of topics, including the online and offline admission process, contracts with vendors (software developers of admission portals), cost structures, the number of seats available for different disciplines, and the preparation and publication of merit lists during the admissions process. The college's governing board strives to promote a comprehensive learning environment. With the participation of teaching and non-teaching staff, the Principal, in her capacity as the institution's head, assumes the role of leadership in decision-making. There are twelve members in total. The Principal, who also serves as the Secretary, is joined by one President, two government representatives, two nominees from universities, three members nominated by the Teacher's Council, two non-teaching representatives, and one student representative. All academic and administrative goals and policies are carried out by the college principal with the assistance of several committees.

The Principal uses MIS to coordinate and control decisions made on behalf of the College by the Teachers' Council, Governing Body, and IQAC with various committees and subcommittees. Both teaching faculty and non-teaching staff actively participate in its efforts to further the college's development. The college's plans and programmes periodically flow through the overall development. It has been in use for both academic and non-academic purposes for a while now. Its official, non-official, and academic work includes the following:

Several institutional procedures demonstrate decentralisation and participative management, such as the admissions process, the delegation of authority to department heads, the assignment of NAAC work to teaching staff, etc.

- The university exam was administered by assigning distinct tasks to both teaching and non-teaching personnel.
- The examination committee was approved by the principal.
- The procedure involves the teaching and non-teaching staff as well. They draft notices asking pupils to fill out forms and pay examination fees. After they are sent by the university, admit cards are handed over to the students on the college premises.

- For each department, the committee creates a centralised protocol for internal and tutorial exams.
- The University of Calcutta offers the timetable for both theory and practical exams. Additionally, they assign testing locations. With the help of the non-teaching personnel, the committee organises the invigilation duties and distributes the question papers and response scripts to the invigilators in accordance with the timetable supplied by the university.
- The departments, along with the assigned examiners and scrutineers, submit the marks for internal, tutorial, practical, and theoretical examinations onto the site in accordance with the University schedule. After getting the mark sheet from the University college distributes it to the students accordingly.

Promotions are determined by using the API score-based PBAS proforma for the UGC Career Advancement Scheme (CAS). In addition to their academic tasks, faculty members are allocated extra responsibilities and duties for the institute's many extracurricular activities. These are primarily volunteer assignments. The Institute gives these contributions the proper weight in their evaluation as a whole. The heads of the departments, the IQAC, the Principal, and the Promotion Subcommittee examine and validate the PBAS proforma that the faculty member filled out. Faculty members must attend prior to the screening and selection process, as their recommendations for promotions are determined on their API score.

Non-Teaching Staff:

Annual performance reviews and confidential reports are used to evaluate all non-teaching employees. A few techniques are used to evaluate the performance of non-teaching staff. These techniques include evaluating each person's technical contribution, which includes topic knowledge, awareness, productivity, quality, inventiveness, readiness to learn, diligence, etc. In addition, they evaluate behavioural characteristics including acceptable behaviour in groups, timeliness, etc.
